Jack was born on July 9, 1925 in Milwaukee, WI to Sidney and Mildred Pines. Jack was gregarious and the life of the party, with a keen mind and broad smile. A superb singer and dancer, swimmer and competitive skeet shooter, he loved life. But most of all, he loved his wife Shirlee and his children Margie and Tony. Jack and Shirlee spent their 45 years of marriage together dancing, traveling, and living a wonderful life as they raised their children Margie and Tony in Winter Haven and Lakeland.

Jack served in the U.S. Army as a Sergeant during WWII in the European Ardennes and Rhineland campaigns. After the war, he received his BS in Chemical Engineering from MIT, and his MBA from Harvard Business School. He started his career at Westinghouse Electric in the Atomic Energy Division (Nautilus nuclear subs). Moving to Florida in 1954, he began a long successful business career in real estate where he developed shopping malls (e.g. Winter Haven Mall...), commercial and residential projects, citrus and cattle operations.
